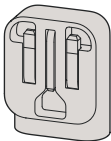


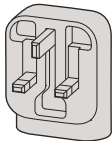

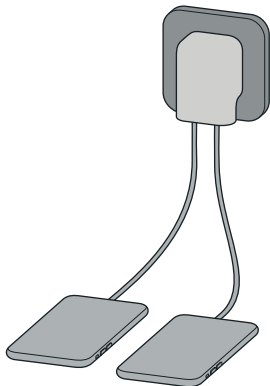
Plug folded
